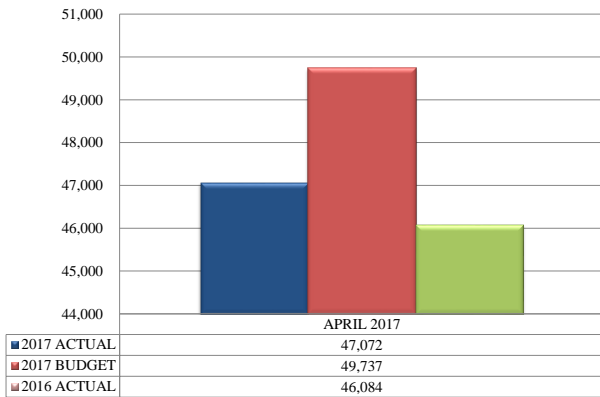

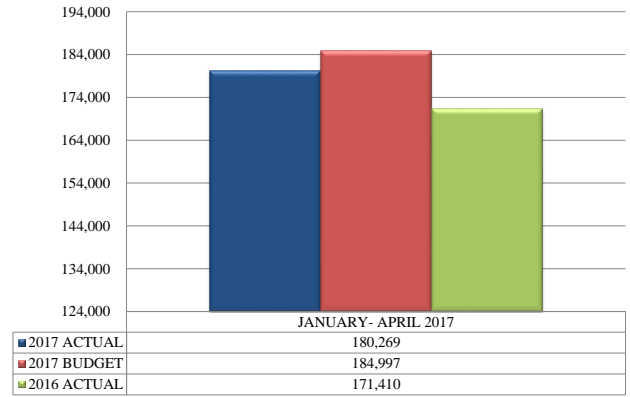

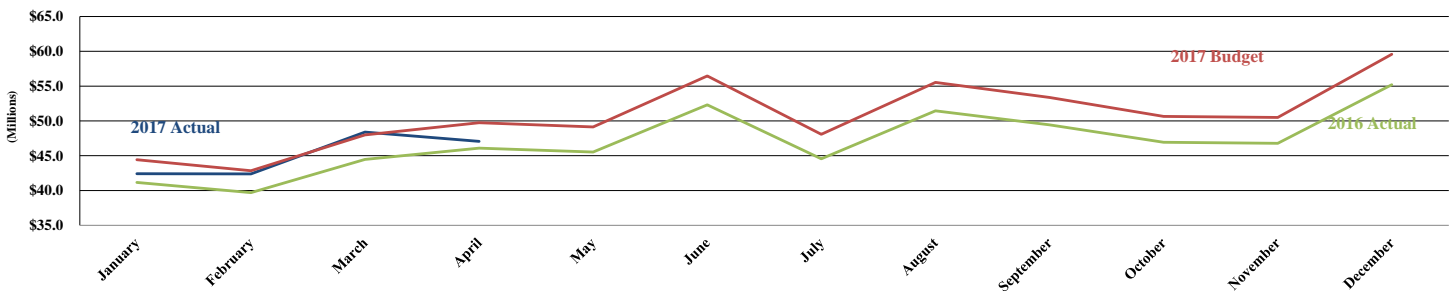
**S&U TAX - APRIL 2017

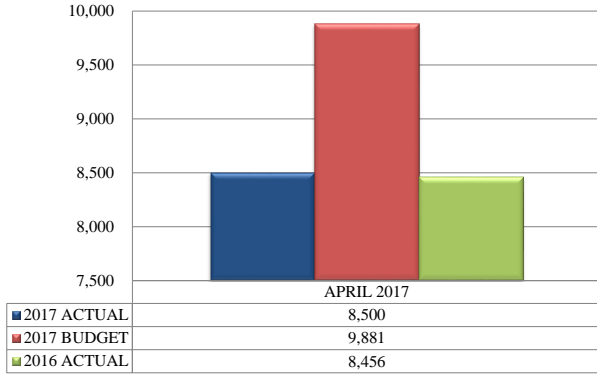




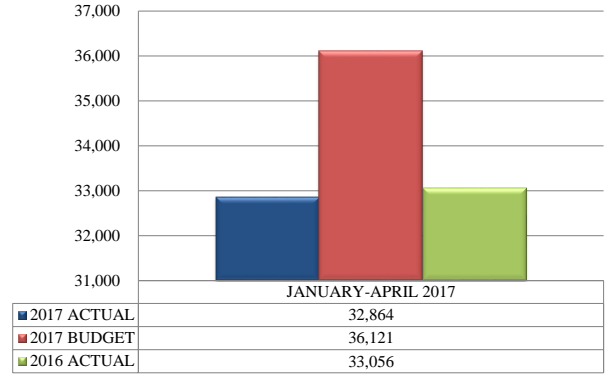

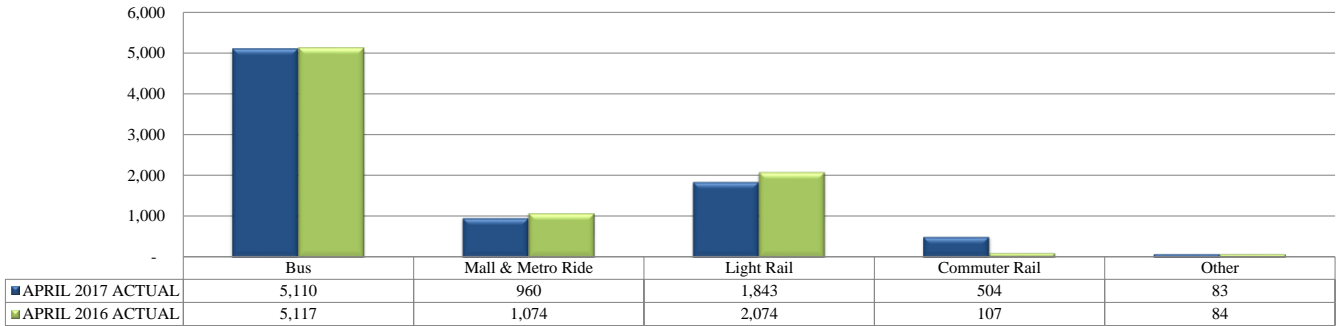
RIDERSHIP - APRIL 2017 ACTUAL VS. BUDGET



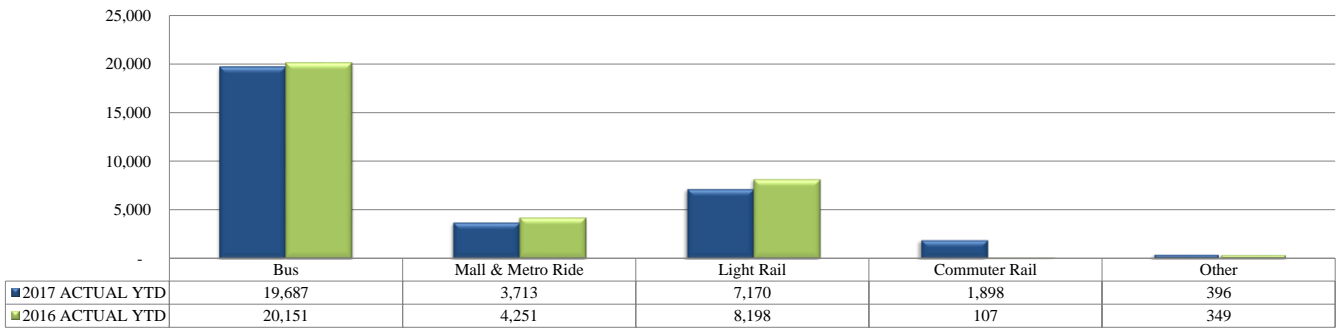
RIDERSHIP - YTD ACTUAL VS. BUDGET



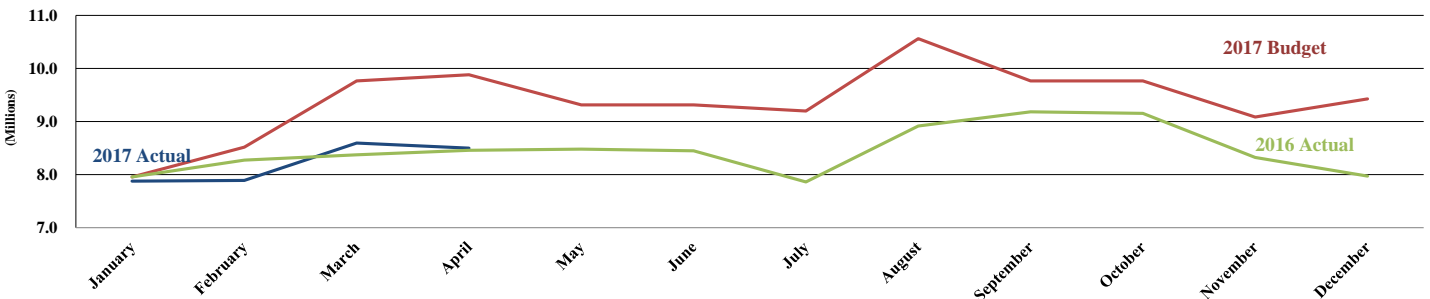
RIDERSHIP BY TYPE - APRIL 2017

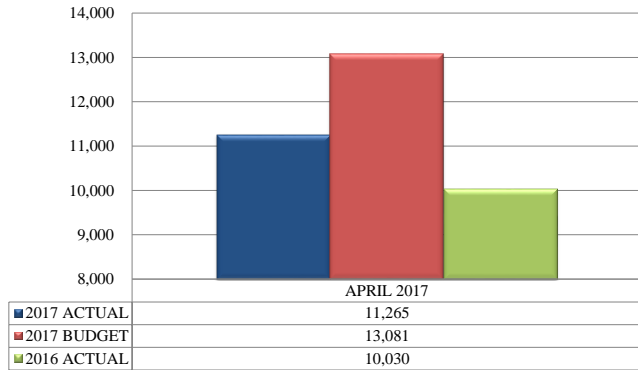

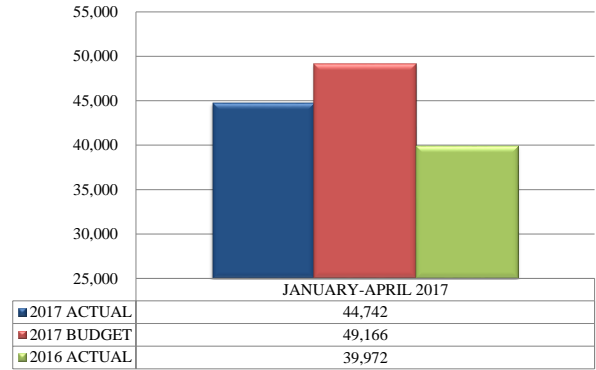

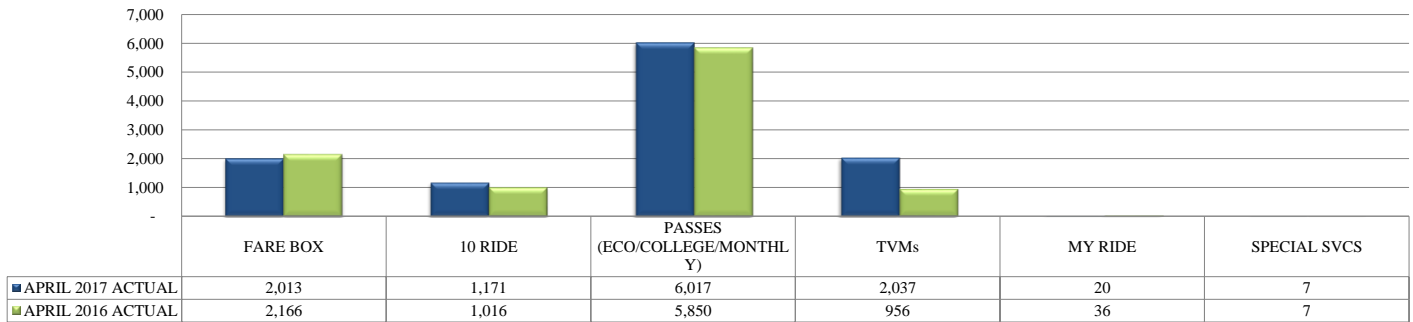
**FARE REVENUE - APRIL 2017
ACTUAL VS. BUDGET**



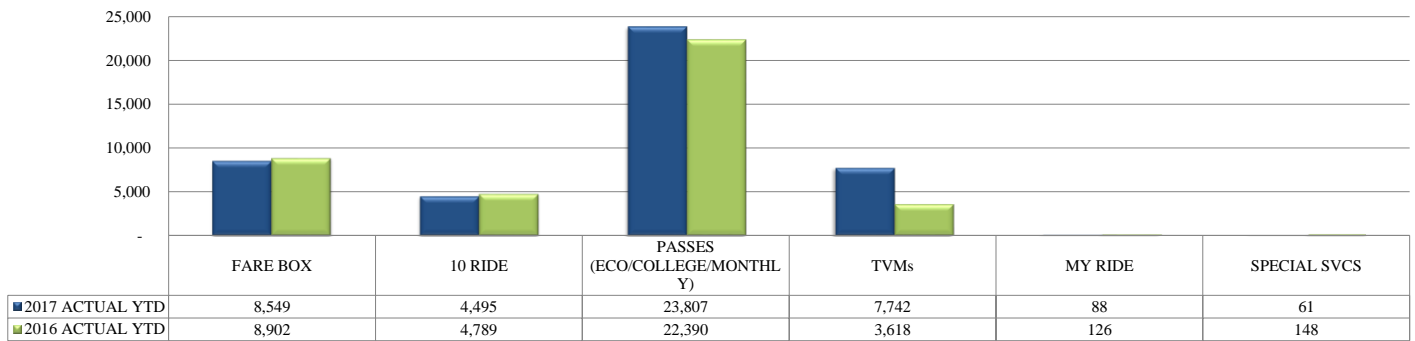
**FARE REVENUE - YTD
ACTUAL VS. BUDGET**



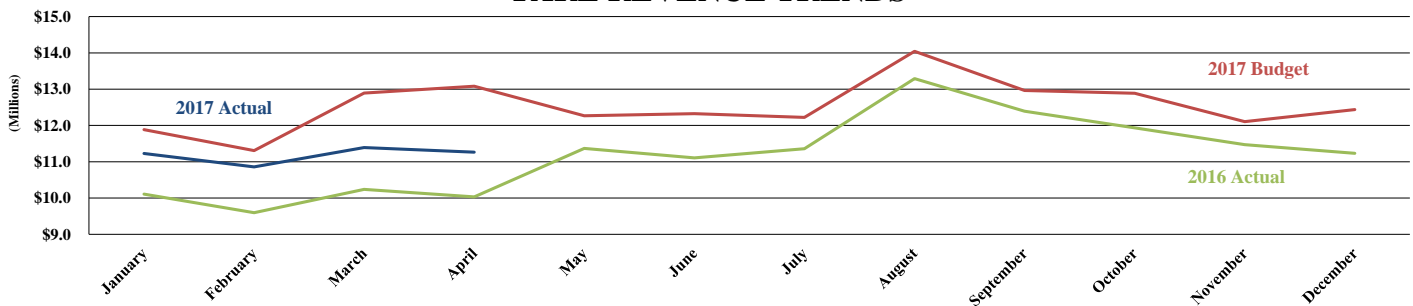
FARE REVENUE - APRIL 2017
